The University of Iowa signed and submitted the Funding Certification and Agreement with the U. S. Department of Education on April 21, 2020 for the CARES funds. There was not a signature requirement for HEERF III. The University agrees to the applicable amount of funds to assist students with emergency grants. The University accepted the terms of the HEERF III grant when it made its first draw of funds (\$50) on 8/18/2021. The remaining funds will be drawn as they are needed for student awards throughout the funding period.

The University of Iowa awarded HEERF III block grants to students that were enrolled in fall 2021, completed a 2021-2022 FAFSA, and did not have grants, scholarships, and/or fellowships that met their cost of attendance, or did not have a quarter time or greater assistantship. The block grants were based on the student's Expected Family Contribution and level of study (undergraduate, graduate, or professional) and ranged from \$750 to \$1,500.

The University of Iowa awarded HEERF III block grants to students that were enrolled in spring 2022, completed a 2021-2022 FAFSA, and did not have grants, scholarships, and/or fellowships that met their cost of attendance, or did not have a quarter time or greater assistantship. The block grants were based on the student's Expected Family Contribution and level of study (undergraduate, graduate, or professional) and ranged from \$670 to \$1,450.

Enrolled students who are not eligible to file the FAFSA (i.e. International, Deferred Action for Childhood Arrivals, undocumented) were notified by email of the opportunity to complete a HEERF III application and explain their exceptional financial need. Students certified their information was accurate and applications were reviewed on an individual basis. Students that have grants, scholarships, and/or fellowships that met their cost of attendance or have a quarter time or greater assistantship were not eligible for funds.
