The University accepted the terms of the HEERF II grant when it made its first draw of funds (\$50) on 3/30/21. The remainder of funds (\$8,085,627) was drawn on 5/5/21.

The awards ranged from \$300 to \$2000 based on the receipt of a Pell grant, acceptance of loan funds, and EFC.
